Additionally, we supported two significant events for our members: Tablon and Anderson.

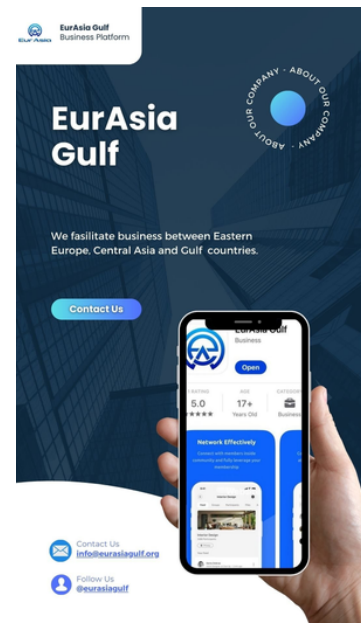
We also had the honor of hosting a business delegation from the Moscow Region, further strengthening our connections.

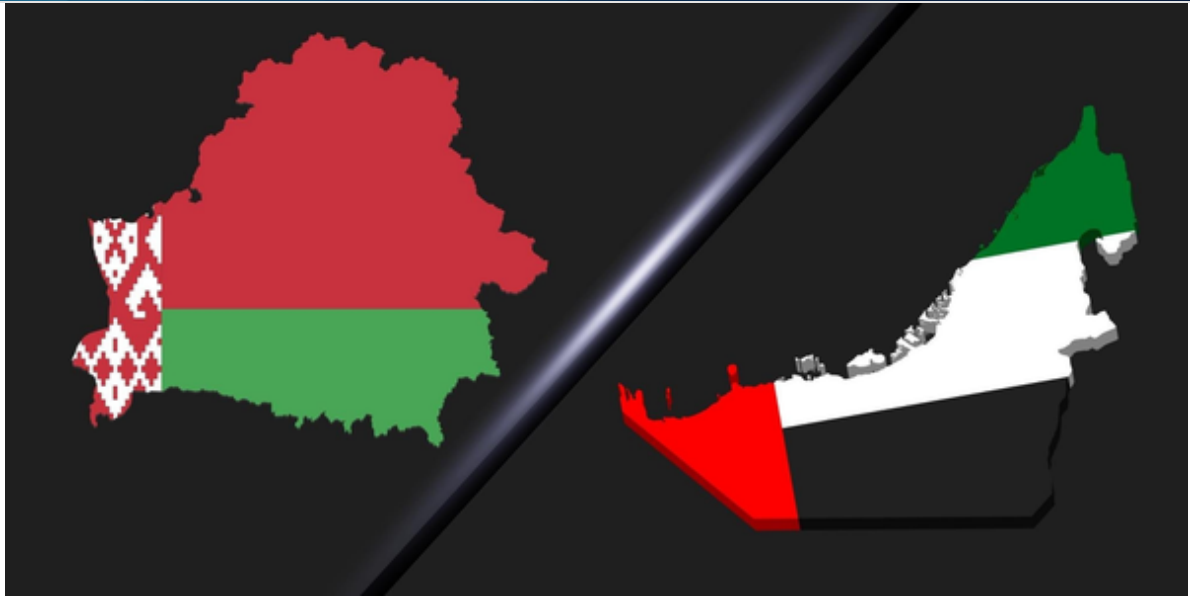
