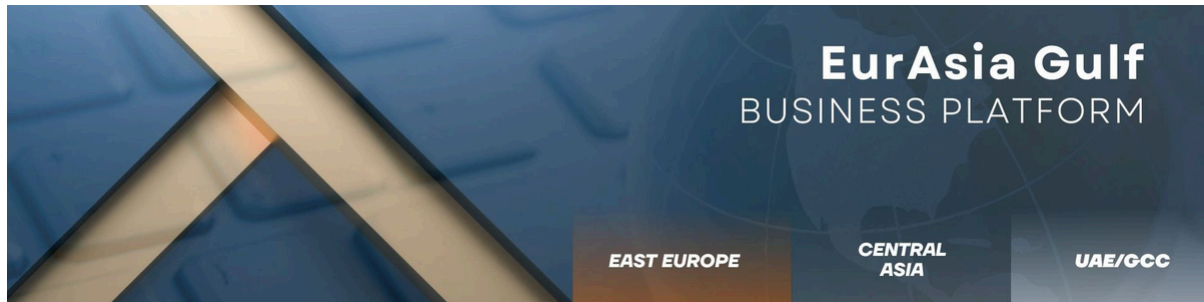




Dear Members and Supporters,

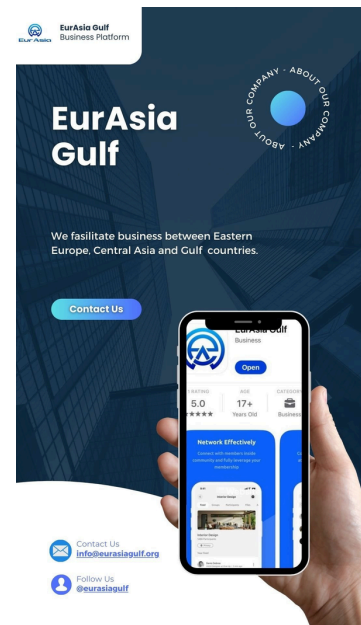
